**Certification of elastomeric bearings according EN 1337-3**

Dear Mr. Stephen Edward,

The MPA University of Stuttgart, notified product certification body (NB 0672) according to the European Construction Products Regulation (CPR), has carried out and finished the certification of elastomeric bearings according to the European standard EN 1337-3 on behalf of the manufacturer MAURER SE Munich, Germany, in the manufacturing plant MAURER do Brasil, Guarulhos, São Paulo. As part of the initial inspection, all controls were carried out in the manufacturing plant as well as the tests on prototypes of elastomeric bearings were completed. The certificate of constancy of performance 0672-CPR-0945 was issued.

The regularly inspection, which is required in the European Construction Products Regulation is carried out by MPA University of Stuttgart several times a year at manufacturing plant. The inspection includes the controls in the manufacturing plant as well as the assessment of the test results regarding the routine testing on elastomeric bearings according EN 1337-3.

No further tests on elastomeric bearings are necessary for customer orders.
